INFORMATION ON PERSONAL DATA PROCESSING

According to art. 13 of the GDPR Regulation:

1. Data Controller

2. Data Protection Officer

3. Purposes for data processing and legal grounds

Your personal data are processed in order to register for the participation in the "International Summer School for PhD Students on METHODS AND TECHNOLOGIES FOR ENERGY TRANSITION AND CLIMATE PROTECTION", to communicate with participants in order to organize the summer school, to prepare documentation of the course and to send information about scientific events by the Silesian University of Technology in the future.

The legal grounds for the processing of personal data: Article 6 paragraph 1 point e of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L 119, p. 1), hereinafter referred to as "GDPR", in connection with the Act of 20 July 2018.

The Law on Higher Education and Science (Journal of Laws, item 1668) and the mission pursued by the university, which is conducting scientific activity, shaping civic attitudes, as well as participation in social development and creating an economy based on innovation.

4. The period of personal data processing

The personal data provided by you in relation to your participation in the summer school will be kept for a period of 5 years from the completion training

5. The obligation to provide data and the consequences of not providing data

Providing data is voluntary, but necessary to achieve the goals for which they were collected.

6. Data recipients

If the data controller uses the services of other entities, personal data may be disclosed to them on the basis of contracts entrusting the processing of personal data, and these entities will be obliged to preserve the confidentiality of data being processed.

7. Rights related to data processing

You have the right to request access to the content of your data and the right to: rectification, deletion, limitation of processing, raising objections.

8. Information about not making decisions in an automated way

On the basis of your personal data, no decisions will be taken that rely solely on automated processing, including profiling.

9. The right to file a complaint to the Inspector General for the Protection of Personal Data

You have the right to lodge a complaint to the Inspector General for Personal Data Protection if you decide that the processing of personal data concerning you infringes the GDPR.

Moreover, we would like to inform you that in order to prepare documentation of this scientific event, the photographs will be taken during the event, which will be published on websites belonging to the Silesian University of Technology.
